

# 2021-22 TUITION AND FEES

## St. Eugene School 707 Tuckahoe Road, Yonkers, NY 10710

Education carries many costs – technology upgrades, resource materials, personnel, building maintenance, utilities – all with increasing price tags. Tuition is significantly lower than the actual cost to educate each child due to the commitment of the Archdiocese and His Eminence Timothy Michael Cardinal Dolan to Catholic education. Teachers, administrators and staff work together to ensure that our schools are Christ-centered, academically excellent, and welcoming communities, preparing students to be life-long learners and leaders energized by fidelity to Christ, the Church, and one another.

### Tuition (K-8)

The annual tuition for 2021-2022 is \$7,400.00. The Archdiocesan Family Grant is \$1,600.00 per eligible child.

### Additional Fees

Registration Fee:	\$225.00 <b>per child</b> ; incentive rate of \$125.00 per child if registration is completed by April 15, 2021
SMART Tuition Admin Fee:	\$40 <b>per family</b> (payable in the first billing month)
Family Fundraising Fee:	\$300 (Payable in 3 payments August, November, & March)
Graduation Fee (K grade):	\$25 (Payable in April)
Graduation Fee (8 <sup>th</sup> grade):	\$300 (Spread from December to April)
Technology Fee	\$375 (Payable in August- Only for students moving up to 6 <sup>th</sup> grade and New students to 7 <sup>th</sup> & 8 <sup>th</sup> grades)

The annual tuition and fees are billed over 11 months from August to June. Your SMART tuition account can only be activated when enrollment in TADS is completed and the registration fees are paid for **all** children attending. (Late enrollment will shorten the payment period available, increasing the monthly payment.) Tuition and fees must be paid directly to SMART Tuition by the designated due date. Payments cannot be accepted at the school.

- (1) Archdiocesan Family Grant: Tuition reduction for families who have two or more siblings residing at the same address, and enrolled full time at this school (does not include UPK students).
- (2) Annual Tuition Obligation: This amount will be lower if you are eligible to apply for and receive financial aid, or are the recipient of a legacy or transfer grant.
